In general, naturalization was a two-step process\* that took a minimum of five years. After residing in the United States for two years, an alien could file a "declaration of intention" ("first papers") to become a citizen. After three additional years, the alien could "petition for naturalization" ("second papers").

## **Naturalization Records | National Archives**

U.S. naturalization records document the process whereby an individual born in another country (an "alien") is granted citizenship in the United States.

Although the details and requirements have changed over the years, the

naturalization process generally consists of three major steps: 1) the filing of a declaration of intent or "first papers," and 2) the petition for naturalization or "second papers" or "final papers," and 3) the granting of citizenship or "certificate of naturalization."
