The Football Spectators Act 1989 is an Act of the Parliament of the United Kingdom enacted during the premiership of Margaret Thatcher. Its provisions apply primarily to football matches played in England and Wales.

Amendments to the Act were made through the Football (Offences and Disorder) Act 1999, the Football (Disorder) Act 2000, and the Violent Crime Reduction Act 2006, the last of which repealed large sections of the Football Spectators Act 1989.

Spectator safety at football grounds was a major concern during the 1980s, following incidents of hooliganism, and disasters such as the Bradford City stadium fire and the Heysel Stadium disaster in 1985, and the Hillsborough disaster in 1989. The Taylor Report into the Hillsborough tragedy was finalised in January 1990 and recommended the removal of terraces (standing areas) in favour of seating.
